


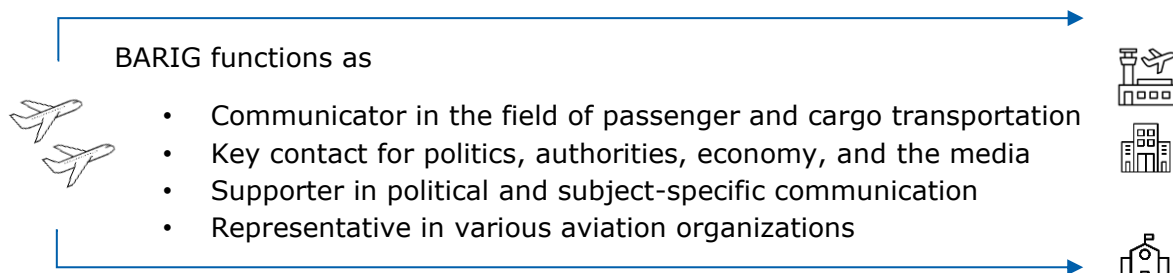

Key Topics

- **Aviation and Climate:**
 - Support the measures presented by the European Commission in the "Fit for 55" package while simultaneously preventing competitive distortions and carbon leakage
 - Use carbon pricing systems such as EU ETS and CORSIA as global, market-based instruments for climate protection
 - Foster "Sustainable Aviation Fuel" (SAF) and achieve a competitively neutral, climate-friendly, and economically efficient configuration of a blending quota as well as of emissions trading
 - Implement a more efficient and climate-friendly common airspace management in Europe with the "Single European Sky" (SES)
- **Air Traffic Tax:**
 - Support the proposal of introducing a Europe-wide levy that is related to the passenger and final destination and similar to the German air traffic tax
 - Use the revenues from the air traffic tax for the future development of alternative fuels and fleet modernization



- **Infrastructure:**
 - Develop further Germany as an aviation location in line with demand
 - Drive forward the expansion of rail infrastructure and connect more airports to the rail network in a targeted manner
- **Air Cargo:**
 - Implement uniform rules for the EU, especially regarding freight security controls, taxes, and customs clearance
 - Optimize authority processes and drive forward digitization of handling procedures
